- i. Council Tax Support Grant was erroneously included within the precept at Box 2 rather than other receipts at Box 3.
- ii. Fixed Assets at Box 9 for the year ending March 2016 correctly included an asset owned by the Council but previously not included. However, the prior year (2014/15) figure had not been restated.

In future, the Council should ensure the Annual Return is accurate and complete.
