- Charlie, Pippa, Michael Reilly and Duncan Mack in attendance
- Charlie confirmed the plans had been shown to current tenant
- Charlie walked through the presentation created for the PC Meet on the 8th March; all good to go!
- This included a video from a similar project in North Martson that project raised £120,000 in funds
- Also referenced other projects including Tiddenfoot, Wendover woods and Watermead (which demonstrates what shouldn't be done)
- Cost forecasts have been created along with funding opportunities. The mantra is that development has to be funded by fundraising, and that it must be self-sufficient with no drain on PC funds
- Following on from the surveying work from Chris Howard, Charlie will create a 3D model for the village fete.
- Initial reaction from 23 villagers shown the plan have been positive
- All terms of reference have been met, including walking through the plans with the current tenants The Lighfoots
- The whole scheme could generate a number of planning issues, which Pippa is researching. Pippa's view is that the plan needs to be run past Aylesbury Vale to understand if there are any planning hoops that need to be gone through
